

## **Morgan Wallen Concert Ticket Giveaway Rules & Regulations**

**Eligibility:** The Morgan Wallen concert ticket giveaway contest (hereinafter referred to as the "Contest") is open to all residents of Clarksville, TN and surrounding areas. Employees of Gentry Orthodontics and their immediate family members are not eligible to participate.

**How to Enter:** Participants can enter the Contest by completing any of the following actions:

- b. Refer a new patient to Gentry Orthodontics.
- c. Accept a treatment plan recommended by Dr. Gentry.
- d. Send a picture wearing/using Gentry Orthodontics swag via text, email, or post it on our social media platforms.
- e. Demonstrate excellent compliance during orthodontic treatment, as determined by Dr. Gentry.
- f. Like, follow, or share any Gentry Orthodontics social media platform.
- g. Wear/use Gentry Orthodontics swag to your appointment.

**Entry Period:** The Contest begins on February 1, 2024 and ends on April 18, 2024. Entries received after the end of the Entry Period will not be considered.
